**BUSD** – Erin Biber reported that BUSD held a job fair and was able to recruit some candidates. They continue to have their monthly parent meeting. This month's topic is the peer buddy program. Benicia will be hosting the Special Olympics basketball on Saturday, March 23, 2024.

**DUSD** – No Report

**FSUSD** – Nicole Smith reported that FSUSD was able to hire ten paraprofessionals at their recent job fair. FSUSD has another job fair coming up on Saturday, March 23, 2024. They have hired a new speech-language therapist and three new school psychologists starting next school year. FSUSD is still relying on a few itinerant case managers to help with caseloads. They have concluded the training for their mild to moderate teachers to now be qualified as MMSN (Mild Moderate Support Needs). They also provided training for their mild to severe teachers to be qualified as ESNs (Extensive Support Needs). FSUSD is working on arrangements for ESY to be held at Crescent, Crystal, and Armijo.

**TUSD** - Kristie Ballard reported that TUSD is also recruiting for open positions for this year and next. They are starting the prep for ESY. TUSD will be hosting its Special Olympics on April 30<sup>th</sup>. Special Olympics came and met with their student leadership team, who will help run the event.

**VUSD** – Absent

**SCOE** – Ilah Feeney reported that SCOE is getting ready to help their preschool and elementary students attend the Dixon May Fair this year. The adult students are getting ready for their Spring Fling dance. The chili cookoff

event was a resounding success. A new class won, dethroning the reigning champions. Right now, SCOE is concentrating on professional learning on parent engagement in IEPs and inclusion across all districts.

#### **2024 LEGISLATIVE SHARING PRIORITIES**

California must ensure students with disabilities have meaningful access to a quality education to acquire the skills needed to go on to higher learning, secure stable employment, and live independently as adults. Along with students and families, Special Education Local Plan Area (SELPA) Administrators and our statewide educational allies are partnering with legislators to destigmatize access to needed special education supports and services by using appropriate language and terminology. SELPA Administrators' state legislative priorities are as follows:

#### **SPONSORED LEGISLATION**

Support: AB 2173 (Addis): Reducing Stigma in Education Act

Ask: Support AB 2173

**Background:** The Individuals with Disabilities Education Act (IDEA) is a federal law that ensures free and appropriate public education to eligible children with disabilities. Within the IDEA, there are thirteen categories of disability that establish eligibilities for special education services. One of these thirteen categories is classified as "emotional disturbance". This term in the federal IDEA law is an outdated and potentially offensive term, which is currently used to describe a large group of children with special needs in California's public education system. AB 2173 allows the term "emotional disability" to replace "emotional disturbance" for educational purposes by stipulating that the two terms are substantively the same under California Education code and regulations. The time has come to move away from this outdated terminology that serves to further isolate and stigmatize students already working through serious social and emotional challenges.

#### **SUPPORTED LEGISLATION**

Support: AB 2026 (Mathis): Disabilities: person-first terminology

**Ask:** Support AB 2026

**Background:** AB 2026 makes technical changes throughout provisions of Health and Safety Code and Welfare and Institutions Code to support the use of person-first terminology. Person-first language emphasizes the person before the disability, for example, "child with a disability" vs "disabled child." This honors the fact that the child has more to them than their disability.
