Sealed Bids will be received until 2:00 p.m., November 18, 2021 at the Solano County Office of Education, 5100 Business Center Drive, Fairfield, California, after which time the bids will be opened and publicly read aloud, in the Blue Rock Springs conference room at the Solano County Office of Education. Any claim by a bidder of error in its bid must be made in compliance with section 5100 et seq. of the Public Contract Code. Any bid that is submitted after this time shall be non-responsive and returned to the bidder.
- 3. The Project consists of:

Tenant improvement to an existing portable building. Removal of all interior walls and reconfiguring the interior building layout. All associated plumbing, mechanical, electrical and finishes. Installation of new concrete walk and ramp with landscaping, irrigation and fencing modifications.

 - a bid bond issued by an admitted surety insurer on the form provided by the SELPA,
 - cash, or
 - a cashier's check or a certified check, drawn to the order of the Solano County SELPA

in the amount of ten percent (10%) of the total bid price. This bid security shall be a guarantee that the Bidder shall, within seven (7) calendar days after the date of the Notice of Award, enter into a contract with the SELPA for the performance of the services as stipulated in the bid.

- 7. The successful Bidder shall be required to furnish a 100% Performance Bond and a 100% Payment Bond if it is awarded the contract for the Project.
- 8. The successful Bidder may substitute securities for any monies withheld by the SELPA to ensure performance under the Contract, in accordance with the provisions of section 22300 of the Public Contract Code.
- 9. The successful Bidder and its subcontractors shall pay all workers on the Project not less than the general prevailing rate of per diem wages and the general prevailing rate for holiday and overtime work as determined by the Director of the Department of Industrial Relations, State of California, for the type of work performed and the locality in which the work is to be performed within the boundaries of the SELPA, pursuant to sections 1770 et seq. of the California Labor Code. Bidders and Bidders' subcontractors shall comply with the

registration and qualification requirements pursuant to sections 1725.5 and 1771.1 of the California Labor Code.
