# Community Advisory Committee Annual Report to Council of Superintendents Activities of 2021-22 School Year Solano County Special Education Local Plan Area

The Community Advisory Committee of Solano County SELPA had a busy and productive session during the 2021-22 school year. The committee typically meets on the third Thursday of the month and due to the pandemic meetings were held via a mix of in person and zoom platform this year. Members include parent representatives nominated by each school district, district administrators and representatives from community-based agencies. These meetings are scheduled from noon to 2:00 p.m. and follow a calendar of varied discussion topics and activities. Standing agenda items are updates from districts and member agencies, and updates from the SELPA Assistant Superintendent. Officers for 2021-22 school year were Kerry Pilley Purcell and Cathy Daily as Co-Chairs.

The primary mission of the CAC is to advise the Solano SELPA and its member LEAs on issues and concerns that are particularly significant to the parents of students with special needs. Highlights of this year's activities include the following:

- Our 16th Annual Special Education Awards Recognition Ceremony was unfortunately cancelled due to the pandemic. Certificates and trophies were sent out to the Special Education Directors to present to their nominated staff.
- Legislative Information Sharing Day was held virtually on May 4<sup>th</sup> and the group was able to meet with all of the regions legislative members, or their representative.
- We were able to offer presentations on a varied number of topics. Some of interest were Vacaville Parks
  and Recreation Therapeutic Recreation Program, the Law Office of Alexis Lynch presented on
  Conservatorships, Tobias Weare from the California State Council on Developmental Disabilities
  presented on Emergency Preparedness, Alexis Jarreau from the Found It agency presented on social
  opportunities for young adults, The Department of Rehabilitation presented on a guide to student
  services and Steve Diamond from Matrix Parent Network and Resource Center presented on services
  they provide families and guidance regarding how to navigate systems that serve families of children
  with special needs.

The CAC looks ahead to the 2022-23 school year and to serving the community with a renewed approach to offering parent education in collaboration with individual districts. District directors are committed to recruiting new parents who can serve in this advisory capacity as some members are no longer able to attend meetings.

In accordance with California Education Code § 56207 and the Solano County SELPA Local Plan, the Vacaville Unified School District is providing formal notice of intent to transfer the following programs from Solano County Office of Education operated Moderate/Severe classrooms to Vacaville Unified School District operated Moderate/Severe classrooms:

In preparation for this transfer, VUSD will be working with the Solano County SELPA to launch a study to ensure that the process and parameters of the transfer are compliant with Ed.Code §56207 by addressing the following:

- 2. The availability of the full continuum of services to affected pupils.

- 3. The functional continuation of the current individualized education programs of all affected pupils.
- 4. The provision of services in the least restrictive environment from which affected pupils can benefit.
- 5. The maintenance of all appropriate support services.
- 6. The assurances that there will be compliance with all federal and state laws and regulations and special education local plan and policies.
- 7. The means through which parent and staff were represented in the planning process.

Should the results of this study determine that VUSD cannot support the program transfer and/or fully comply with Ed.Code §56207, notice to terminate this transfer will be provided to the Council of Superintendents and the Solano County Office of Education within the one year and one day notice period. This notice shall provide time for SCOE to plan for the 2023-24 school year.

While the District has not made a final determination, we are issuing this notice of transfer to preserve our option of providing services to our, and possibly other interested LEAs, students currently enrolled in SCOE moderate/severe programs beginning July of 2023. VUSD looks forward to collaborating with our other SELPA District partners throughout the 2022-23 school year in preparation for this possible change.
